• "ARTAR TABLETS", taken once a day, reduce nervous excitement caused by vehicle sway and acceleration, and reduce or relieve the occurrence of dizziness, nausea and headache caused by motion sickness. If you take about 30 minutes before getting on a car, ship, airplane etc, you will be relieved from unpleasant motion sickness, thereby making travel and hobbies more fun.

For the prevention and treatment of dizziness, nausea, headache associated with motion sickness.

Do not use for child under 7 years old.

1 While taking this medicine, please do not take any of the following medicines.

Other medicines such as motion sickness medicine, cold medicine, antipyretics, analgesics, sedatives, antitussive expectorants, gastrointestinal analgesic antispasmodics, internal medicines containing antihistamine etc. (internal medicine for rhinitis, allergy medicine etc.)

2 Do not drive a motor vehicle or operate machinery after using this medicine. (Symptoms such as drowsiness, blurred vision, dazzling sunlight may occur.)

- 1 The following persons should consult a doctor, pharmacist, or registered distributor before using this medicine.
- (1) A person undergoing medical treatment from a doctor.

[When using this product]

- (1) Please follow the recommended dosage and directions.
- (2) This medicine should be given to children only under adult supervision.
- (3) When using this medicine for the first time,

Please push the projection of the PTP sheet containing tablets strongly with your fingertips as shown below, break the aluminum sheet on the back side, push out and take it.

(If you mistakenly swallow the PTP sheet as it is, it leads to an unexpected accident such as stabbing into the esophagus mucosa.)



(4) This medicine can be drunk without water, but if you melt in the mouth, bitterness comes out, please swallow early.

Other information

- (1) Store in a cool and dry with less humidity place free from direct sunlight.
- (2) Keep all medicine out of the reach of children.
- (3) Do not transfer this medicine to a different container. (In this case, cause misuse or change quality.)
- (4) If you will use the rest half of one tablet, wrap it in the clean paper, store in the outer box, and take it within 2 days.
- (5) Please do not take products that have passed the expiration date.
