### Precautions

#### ⊗ When not to use the product

(If you do not follow these instructions, the current symptoms may worsen or adverse reactions are more likely to occur.)

1. Please the medicine should not be used on the following parts:A person with candidiasis
2. Please the medicine should not be used on the following parts:Periorbital area、Mucosa



#### Consult a doctor for the following

1. The following persons should consult a doctor, pharmacist, or registered salesperson before using this medicine.

- (1) Patients undergoing medical treatment from a doctor.
  - (2) Pregnant women or women suspected of being pregnant.
  - (3) Patients who have experienced allergic symptoms associated with drugs, etc.
  - (4) Those with severe moistening or erosion
  - (5) Infants
- 2. If the following symptoms appear after use, it may be a side effect, so stop using it immediately and consult your doctor, pharmacist, or registered salesperson with this case.**

## Dosage and administration

Apply an appropriate amount to the affected area several times a day.

## When using this product

- (1) Please do not leave the affected lesion and surrounding area soiled when using this medicine.'
- (2) This medicine should be given to children only under adult supervision.
- (3) Attention should be paid so that the medicine will not come into contact with eyes. If the medicine comes into contact with eyes, immediately rinse them with water or lukewarm water. If the symptoms are severe, seek an ophthalmologist for medical treatment.
- (4) Please use only for external treatment.
- (5) Avoid using other topical agents in the same area.

## Precautions for storage and handling

- (1) Store in a cool, low humidity place away from direct sunlight by a seal tightly.
- (2) Keep all medicine out of the reach of children.
- (3) Do not transfer this medicine to a different container. (In this case, cause misuse or change quality.)
- (4) Do not use this medicine past their expiration date.

## Warning

Itching caused by candidiasis, trichomoniasis, etc. requires fundamental treatment by a doctor.

Contains glyceryl monostearate, polysorbate 60, polyoxyethylene hydrogenated castor oil, parabens, stearyl alcohol, cetanol, propylene glycol, carboxyvinyl polymer, diethyl sebacate, and triethanolamine.
