The main component, prednisolone valerate ester acetate, is a type of steroid drug called antedrug. Antedrugs are medicines that exert their effect on the affected area of the skin surface and become less active when absorbed into the body.

Prednisolone valerate ester acetate and dipotassium glycyrrhizinate, which suppresses inflammation such as eczema and hives, are combined with diphenhydramine hydrochloride, crotamiton and lidocaine to reduce itching.

Panthenol promotes skin repair. Isopropyl methyl phenol has a bactericidal effect. I-menthol and dl-camphor give a refreshing sensation and reduce itching.

This medicine is a clear liquid based on alcohol, and it can be refreshingly applied by lightly applying to the affected area, and it is well-adapted to the skin, dries quickly, does not stick and does not stain clothing.

Uses

Alleviation of the symptoms by insect bites, itching, eczema, dermatitis, rash, hives, heat rash.

Warnings

[To be avoided]

(Failure to observe the following may result in the current symptoms worsening or adverse reactions occurring.)

- 1. Do not use for the next part:
- (1) A person who has the affected areas with chicken pox (water pox), Athlete's foot (Tinea pedis). Ringworm in the groin, etc. and/or who have purulent on the affected part.
- (2) Wound surface, around eyes, mucous membranes etc.
- 2. Please do not use it extensively on the face.
- 3. Do not use long-term continuously.

[Consult a doctor for the following]

- 1. The following persons should consult a doctor, pharmacist, or registered distributor before using this medicine.
- (1) A person undergoing medical treatment from a doctor.
- (2) A pregnant woman or a woman suspected of being pregnant.
- (3) A person with a medical history of being allergic to medicines and other substances.
- (4) The affected area is spreaded on the wide.
- (5) A person with wet or awful sore on the affected part.
- 2. The following symptoms may be adverse reactions to this medicine. If any of these symptoms occur, discontinue use immediately and consult a doctor, pharmacist, or registered distributor with the Japanese package insert.

Directions

Apply an appropriate amount to the affected area several times a day

[When using this product]

- (1) Remove the cap, gently press the sponge part against the skin 1 to 2 times, please use this medical fluid after impregnating the sponge.
- (2) Please follow the prescribed usage and dose.
- (3) This medicine should be given to children only under adult supervision.
- (4) Be careful not to get into eyes. If it gets in your eyes, please wash immediately with water or lukewarm water.
- (5) Please use only for external treatment.

Other information

- (1) Store in a cool and dry with less humidity place free from direct sunlight by a seal tightly.
- (2) Keep all medicine out of the reach of children.
- (3) Do not transfer this medicine to a different container. (In this case, cause misuse or change quality.)
- (4) Do not get close to fire. In addition, please do not throw in fire after use
- (5) Because this medicine contains volatile ingredients, please close the cap tightly after use.
- (6) Please do not touch your eyes or mucous membranes with your hand wearing this medicine.
- (7) Be careful not to adhere to metal objects such as glasses, watches and accessories, clothing, plastics, leather products, and painted surfaces such as floors and furniture, as they may deteriorate or discolor.
- (8) Do not use products that have expired. Please use as soon as possible from the point of quality maintenance even within the expiration date after opening

Inactive ingredients:

Dibutylhydroxytoluene, 1,3-Butylene glycol, Ethanol, Citric anhydride, and Sodium citrate hydrate.
