This external preparation contains the non-steroidal anti-inflammatory drug ufenamate as the main ingredient, diphenhydramine and glycyrrhetic acid to suppress itching and inflammation, and benzethonium chloride, which has sterilizing and disinfecting properties.

Can be used on the face, arms, and body of everyone from infants to adults. A refreshing cream that gently blends into the skin.

Diphenhydramine 1.0g .....	Anti-histamine action

Benzethonium chloride 0.1g .....	Anti-itching ingredient

**【Consult a doctor for the following】**

1. The following persons should consult a doctor, pharmacist, or registered salesperson before using this medicine.
  - (1) Patients undergoing medical treatment from a doctor.
  - (2) Patients who have experienced allergic symptoms associated with drugs, etc.

(3) People with severe dampness or sores.

2. The following symptoms may be adverse reactions to this medicine. If any of these symptoms occur, discontinue use immediately and consult a doctor, pharmacist, or registered salesperson registered seller with this case or this Japanese product manual.

If symptoms do not improve after using between 5 and 6 days, stop using the medicine, consult a doctor, pharmacist, or registered salesperson registered seller with this case or this Japanese product manual. the Japanese instructions written on this package case, and consult a doctor, pharmacist or registered salesperson.

### **[Dosage and administration]**

Apply an appropriate amount to the affected area several times a day.

### **[When using this product]**

- (1) This medicine should be given to children only under adult supervision.
- (2) Be careful not to get it in your eyes. If it gets into your eyes, immediately wash it with water or lukewarm water. If the symptoms are severe, please consult an ophthalmologist.
- (3) For external use only.
- (4) Apply after cleaning the affected area.

### **[Precautions for storage and handling]**

- (1) Store in a cool and dry with less humidity place free from direct sunlight by a seal tightly.
- (2) Keep all medicine out of the reach of children.
- (3) Do not transfer this medicine to a different container. (In this case, cause misuse or change quality.)
- (4) Do not use the product that has passed its expiration date (listed on the outer box).

**Inactive ingredients:**

Contains petrolatum, stearyl alcohol, cetyl alcohol, glyceryl monostearate, isopropyl palmitate, behenyl alcohol, cetomacrogol 1000, dimethylpolysiloxane, parabens, and dibutylhydroxytoluene (BHT).
