When applying medicine to the skin inside the ear, do not insert the cotton swab deep into the ear, as this may damage the inner part of the ear or the eardrum.

Hold the cotton ball about 1.5cm from the tip (underneath the cotton ball) and apply gently without rubbing.

Precautions when using in ears

- (1) This medicine is not an ear drop, so do not drop it directly into the ear.
- (2) When using on the skin inside the ear, be sure to follow the instructions on the back of the container.
- (3) Please do not use it for a long period of time. (As a guideline, within 2 weeks)
- (4) If you suspect that your eardrum is perforated or have ear discharge, consult a doctor, pharmacist, or registered salesperson before use.
- (5) If you have difficulty hearing after using this medicine, stop using it and consult a doctor, pharmacist, or registered seller with this case or this Japanese product manual.
- (6) The recommended age to start using this medicine is 10 years or older. Please do not use this product on children (under 15 years old).

(7) Do not use earphones or hearing aids immediately after applying this medicine, and make sure they are completely dry before using. (After 1 hour as a guide)

A Precautions

When not to use the product

(If you do not follow these instructions, the current symptoms may worsen or adverse reactions are more likely to occur.)

- 1. Please the medicine should not be used on the following parts.
- (1) Varicella (chickenpox), Athlete's foot/tinea or purulent lesions
- (2) Wound surface, Periorbital area, Mucosa
- 2. Please do not use extensively on the face
- 3. Please do not use this medicine for a long time

Consult a doctor for the following

- 1. The following persons should consult a doctor, pharmacist, or registered salesperson before using this medicine.
- (1) Patients undergoing medical treatment from a doctor.

- (2) Pregnant women or women suspected of being pregnant.
- (3) Patients who have experienced allergic symptoms (Rash, redness, rash, etc.) associated with drugs, etc.
- (4) Those with extensive lesions.
- (5) Those with severe moistening or erosion
- 2. If the following symptoms appear after use, it may be a side effect, so stop using it immediately and consult your doctor, pharmacist, or registered salesperson with this case.

Skin	Rash • redness, itching, swelling, blotch, irritation, heat on skin, dryness, irritability
Skin(Affected area)	Ringworm such as athlete's foot and ringworm, acne, suppurative symptoms, and persistent irritation

3. If symptoms do not improve after using between 5 and 6 days, stop using the medicine, consult a doctor, pharmacist, or registered salesperson registered seller with this case or this Japanese product manual. the Japanese instructions written on this package case, and consult a doctor, pharmacist or registered salesperson.

[Dosage and administration]

Apply an appropriate amount to the affected area several times a day.

When using this product

- (1) Please follow the prescribed usage and dosage.
- (2) This medicine should be given to children only under adult supervision.
- (3) Be careful not to get it in your eyes. If it gets into your eyes, immediately wash it with water or lukewarm water. If the symptoms are severe (such as persistent redness, pain, or unstoppable tearing), please consult an ophthalmologist.
- (4) This medicine is for external use only and should not be taken internally.

(5) If the affected area is scarred, you may feel a sting when you apply it.

How to use the container

(1) Before use, with the tip of the container facing upward, press the tip of the inner stopper 2 to 3 times with your fingers to release the air inside.

(This medicine is to prevent the pressure inside the container from increasing when the container is placed in a hot place, or when the chemical solution is running low, causing a large amount of the chemical solution to come out.)

(2) When using, hold the container top on facing down or diagonally and lightly press the tip onto the affected area to apply. When you remove the tip of the container from the affected area, the liquid will no longer come out.

(If you press it too hard or squeeze the container body too tightly, more liquid will come out.)

Precautions for storage and handling

- (1) Store in a cool place free from direct sunlight by a seal tightly.
- (2) Keep all medicine out of the reach of children.
- (3) Do not transfer this medicine to a different container. (In this case, cause misuse or change quality.)
- (4) Keep away from fire. Also, do not throw it into a fire after use.
- (5) Be careful not to get it on metal objects such as glasses, watches, accessories, plastics, synthetic clothing, leather products, or painted surfaces, and be carful such as floors or furniture, so these cases may cause deterioration.
- (6) If this medicine gets on dyed hair, the color may fade.
- (7) Tighten the cap after use.
- (8) Do not use this product after the expiration date (written on the bottom of the box).
